Application Notes

- All applicable membership and associated fees must accompany this form, as well as proof of identification and residential address.
- Membership fees include the appropriate Affiliation Fees and Golfers Insurance.
- Persons who have attained the age of 18 years shall be eligible for nomination as a 5-year golf Member.
- 5-year golf Members are eligible to be elected as a member of the Board of Directors.
- 5-year golf Members are entitled to vote at any General Meeting of the Club.
- 5-year golf Members are entitled to unlimited Golf free of Green Fees. (All golfers report to the Pro Shop prior to playing - golf subject to course availability with bookings essential).
- 5 Year Golf Members have provision for maintenance of a Golf Handicap.
- Reciprocal arrangements are available with the clubs listed in the current year's Golf Syllabus. This does not include members of the club who reside outside a radius of 85km from the Tocumwal Golf & Bowls
- It is preferable that Applications for Membership be made in person by the person making the application.
- All details requested must be completed and provided before this Application can be processed.
- Applications must be in the hands of the Secretary 14 days prior to the monthly board meeting held on the last Monday or Thursday of each month.
- Persons who have applied for a 5 Year Golf membership shall have "immediate" rights of the category.
- Tocumwal Golf & Bowls Club's membership year runs from the 1st September - 31st August, therefore all members become un-financial as at 1st September each year.
- Tocumwal Golf & Bowls Club's Company Constitution and Privacy Policy are available upon request from Reception.
- The 5-Year Golf Membership does not include annual Clubhouse credit, Motorised Golf Vehicle Fee, Cart Shed Rental or driving range membership. These items will be invoiced on an annual basis.
- The Clubhouse Account amount, will be credited onto the Member's Membership Card and can be used for all clubhouse and pro shop purchases, excluding membership.
- All Members of the Tocumwal Golf & Bowls Club can play in social Bowls events. If members wish to play in competition they must be a Bowls Member, Golf & Bowls Member or Country Bowls Member.
