## Application Notes

1. Any young person who is under the age of 18 years may be admitted as a Junior Member subject to such conditions and restrictions as the Committee may from time to time impose.
2. This includes the appropriate Affiliation Fees and Golfers Insurance.
3. Unlimited Golf free of Green Fees. (All golfers report to the Pro Shop prior to playing – golf subject to course availability with bookings essential).
4. Provision for maintenance of Golf Handicap.
5. Reciprocal arrangements are available with the clubs listed in the current years Golf Syllabus. This does not include members of the club who reside outside a radius of 85km from the Club Tocumwal.
6. Junior Members, once turning 18, will automatically roll over to become Full Golf Members until the end of that current membership year. This does not incur any extra costs.
7. It is preferable that Applications for Membership be made in person by the person making the application.
8. All details requested must be completed and provided before this Application can be processed.
9. Applications must be in the hands of the Secretary 14 days prior to the monthly board meeting generally held on the first Monday of each month.
10. All applicable membership fees must accompany this form.
11. Persons who have applied for junior membership of the Club are admitted as provisional associates. Such persons shall have “immediate” full rights of the category sought.
12. ClubTocumwal’s membership year runs from the 1st September to the 31st August, therefore all members become un-financial as at 1st September each year.
13. ClubTocumwal’s Company Constitution and Privacy Policy are available upon request from Reception.

### BY-LAW 5: JUNIOR PERSONS

1. At all times, junior persons under the age of 15 years must be in the company and under the direct supervision of an adult whilst playing or using any part of the Golf Course, practice facilities, Bowling Greens, or on any part of the Club curtilage.
2. Whilst under supervision there is an expectation that this adult will carefully explain to our junior member the Rules of Golf and Bowls, etiquette and maintenance so as to enable them to become a future responsible player in club competitions.
