Application Notes

1. All applicable membership and associated fees must accompany this form, as well as proof of identification and residential address.
2. Membership fees include the appropriate Affiliation Fees and Golfers Insurance
3. Persons who have attained the age of 18 years but not older than 40 years shall be eligible for nomination as a Golf and Go Member.
4. Golf and Go Members are eligible to be elected as a member of the Board of Directors
5. Golf and Go Members are entitled to vote at any General Meeting of the Club.
6. Golf and Go Members are entitled to unlimited Golf free of Green Fees. (All golfers report to the Pro Shop prior to playing. Golf is subject to availability with bookings essential)
7. Golf and Go Members have provision for maintenance of a Golf Handicap.
8. Golf and Go Members are entitled to Reciprocal arrangements with the Clubs listed in the current years Golf Syllabus.
9. Persons must reside within 80km radius of Tocumwal to be eligible for Golf and Go Membership.
10. Golf and Go Members are eligible to enter club competitions and board events.
11. It is preferable that Applications for Membership be made in person by the person making the application.
12. All details requested must be completed and provided before this application can be processed.
13. Applications must be in the hands of the Secretary 14 days prior to the monthly board meeting held on the last Friday or first Monday of each Month.
14. Persons who have applied for a membership shall have "immediate" rights of the category sought.
15. Club Tocumwal's membership year runs from the 1st of September - 31st of August, therefore all members become unfinancial as at 1st of September each year.
16. Club Tocumwal's Company Constitution & Privacy Policy are available upon request from Reception.
17. All members of Club Tocumwal can play in Social Bowls events. If members wish to play in competition they must be a Bowls Member, Golf & Bowls Member or Country Bowls Member.
