Application Notes

1. All applicable membership and associated fees must accompany this form, as well as proof of identification and residential address.
2. Membership fees include the appropriate Affiliation Fees and Golfers Insurance
3. Persons who have attained the age of 18 years shall be eligible for nomination as a Golf and/or Bowls Member.
4. Golf and/or Bowls Members are eligible to be elected as a member of the Board of Directors (Country Members excluded)
5. Golf and/or Bowls Members are entitled to vote at any General Meeting of the Club (Country Members excluded)
6. Golf & Bowls and Country Golf Members (Bowls excluded) are entitled to unlimited Golf free of Green Fees.
7. Golf & Bowls Members, Golf and Country Golf Over 80km have provision for maintenance of a Golf Handicap.
8. Reciprocal arrangements are available with the clubs listed on the club's website. This does not include members of the club who reside outside a 85km radius of Club Tocumwal.
9. All details requested must be completed and provided before this application can be processed.
10. Applications must be in the hands of the Secretary 14 days prior to the monthly board meeting generally held on the last Friday or first Monday of each month.
11. Persons who have applied for a membership shall have "immediate" rights of the category sought.
12. Club Tocumwal's Membership year runs from the 1st of September - 31st of August, therefore all members become unfinancial as at 1st of September each year.
13. Club Tocumwal's Company Constitution & Privacy Policy are available upon request from Reception.
14. The Clubhouse Credit amount, will be credited onto the Member's Membership Card and can be used for all clubhouse and pro shop purchases, excluding membership.
15. All members of Club Tocumwal can play in Social Bowls events. If members wish to play in competition they must be a Bowls, Golf & Bowls or Country Bowls Member.
16. Persons attaining the age of 18 shall be eligible for nomination as a Country Member Under 80km, on the following terms:
 - 16.1. Must reside under 80kms from Club Tocumwal. Excluding Post Code 2714.
 - 16.2. Must be a Full Golfing Member of your home Golf Club and hold a current AGU Handicap at that Club.
17. Persons who have attained the age of 18 years shall be eligible to be nominated as a Country Golf Over 80km.
 - 17.1 Persons must reside at least over 80kms from Club Tocumwal. Eligibility criteria apply and are determined on radius from Club Tocumwal.
18. Country Members;
 - 18.1. Eligible to enter Club Competitions.
 - 18.2. NOT eligible to play in Club Championships and Board Events.
 - 18.3. NOT eligible to be elected a Member of the Board of Directors.
 - 18.4. NOT eligible to vote at any General Meeting of the Club.
 - 18.5. NOT eligible to Reciprocal arrangements with the Clubs listed on the Club's website.
